- q. Approved 14 CFR Part 141/142 School Graduation Certificate (if applicable)

- s. Current Aeronautical Charts and Airport Facilities Directory (paper or electronic is acceptable)

- u. E6B flight computer (mechanical or electronic or tablet application is acceptable)

Flight plan documentation developed by the Applicant for the assigned flight plan scenario after receipt with Howard, to include FAA 7233-1 or 7233-4 Flight Plan form suitable for filing; navigation log; weather briefing supporting the flight plan; Takeoff & Landing distance computations; Weight & Balance computations; and weather charts applicable to the scenario that are referenced in the applicable ACS or PTS (paper or electronic acceptable)

The following is recommended to be available to the Applicant at the Practical Test:

- w. Current FAR/AIM and any other FAA Advisory Circulars referenced in the ACS or PTS (paper or electronic is acceptable)
- x. Any other reference resources or electronic tools that Applicant might use to make aeronautical decisions – the oral portion of the practical test is “open book”

By submission of this Applicant Information for the FAA Practical Test, Applicant acknowledges that per 14 CFR Part 61.47 that the Applicant will serve as Pilot-In-Command during the flight portion of the Practical Test unless the examiner agrees to act as Pilot-In-Command by prior agreement.

This Applicant Information form should be received by Howard prior to receipt of a telephone call from the applicant to schedule the practical test, and should normally be submitted at least 48 hours prior to the desired date/time of that test.
